Golf Driving Range Regulations

ALL persons who enter and/or use this Driving Range (including but not limited to members, permitted users, parent or guardian accompanying underaged users, guests, visitors) must fully comply with all the following Regulations.

Driving Range General Usage Regulations

1. The facilities and services of the Driving Range are provided for SCAA Members and permitted users only.
2. SCAA Members or permitted users must present valid SCAA Membership Card or authorised document for verification at the Reception prior to using the Driving Range facilities and services.
3. Children under the age of 4 shall not be admitted to the Driving Range unless prior approval is obtained from the Golf Driving Range Management. Users between the ages of 4 and 12 shall be accompanied by parent or guardian. The parent or guardian shall have the responsibility of ensuring the underaged users shall fully comply with all these Regulations.
4. All persons who enter and/or use this Driving Range ARE NOT ALLOWED to:
 - a) Litter, spit or smoke;
 - b) Bring pets into the Driving Range;
 - c) Shout or yell, running around or doing any kind of horseplay;
 - d) Take photograph or video-recording unless prior approval is obtained from our Association;
 - e) Do any coaching or teaching unless the qualified Instructor has obtained prior approval from our Association;
 - f) Display any kind decorations, banners or signs etc. (whether of advertising nature or not), except authorized by our Association
5. All persons who enter and/or use this Driving Range: -
 - a) Must lower the voice level to avoid disturbance to others;

- b) Must take care of their own personal belongings. The Association shall not be held liable for any loss, damage to any personal items, belongings or property
 - c) Shall not remove any facility, equipment or apparatus belonging to the Driving Range, or else, he or she shall be responsible to meet the cost of repair, reinstatement or replacement for any facility, equipment or apparatus damaged or destroyed.
 - d) Shall not use any impolite language or conduct himself or herself in such a manner as to cause any annoyance to other users and/or our staff.
6. All persons who enter and/or use this Driving Range must comply with all the Driving Range Regulations including the Practice Bay Regulations and the Club Rental Regulations. If he or she breaches any of these Regulations, our staff is entitled to request that person to immediately cease using the Driving Range facility including the Practice Bay facility and to leave the premises. If there is any repeated breach, our Association is entitled to refuse that person from entering the Driving Range again or to use the facility.
 7. For all persons who enter and/or use this Driving Range, if due to his or her negligence and/or improper conduct, injury, death, loss or damage to property are caused to any other persons, that person who causes the injury, death, and/or loss or damage to property shall be fully responsible for all legal consequences and shall indemnify the Association for all financial liability incurred including all legal costs and expenses.
 8. All persons in the Driving Range shall not conduct himself or herself in such a manner which is in contravention of the Laws of Hong Kong, the Rules of SCAA or the Regulations of the Driving Range.
 9. The Driving Range Management reserves the rights to close the Driving Range for maintenance, cleaning or for other purposes without prior notice. The Driving Range will also be closed without prior notice due to inclement weather, tropical cyclone or typhoon.
 10. The Driving Range & Locker rooms will be closed not later than 11:00 pm.
 11. Our staff shall have the absolute discretion to decide on the person to be allowed to enter and/or remain in the premises.
 12. SCAA shall have the absolute rights to interpret and to give a final determination on all these Regulations set out in this document. The Association has the right to amend, delete, add or reduce any of these Regulations without prior notice.
 13. In respect of all these Regulations, if there is any inconsistency or ambiguity between the Chinese version and the English version, the Chinese version shall prevail.

Practice Bay Regulations

1. All users must present valid SCAA membership card or authorized document at the Reception for verification. They shall pay all the necessary charges before they can use the Golf Driving Range facilities and services.
2. Non-SCAA Golf Annual Entrance card member must pay the Single Admission Fee per head for each visit.
3. All users shall check the date and time of their booking at the Reception. Fee paid is not refundable under any conditions.
4. The SCAA Membership and the authorized document are not transferable. The user who booked the practice bay must be present during the booked sessions.
5. All users are not allowed to change the designated practice bay without permission of our staff.
6. During the booked session, all users are required to insert the booking receipt in the box placed at the bay for checking by our staff.
7. All user must use the practice balls provided by the Driving Range.
8. All users are required to wear proper golf attire and footwear. They have to comply with the usual golf etiquette.
9. **Gentlemen are strictly prohibited from using DRIVER in this Driving Range. (including G/F and 1/F)**
 - a) G/F :
 - i) Ladies - all clubs can be used including DRIVER
 - ii) Gentlemen - all clubs can be used EXCEPT clubs below 14 degree
 - b) 1/F :
 - i) Ladies - all clubs can be used EXCEPT DRIVER
 - ii) Gentlemen- all iron can be used EXCEPT NO.1 & NO.2 IRON
10. Our staff is entitled to restrict the use of any DRIVER/CLUB(s) on the Driving Range for reason of safety or other management consideration or for any other reason(s).
11. Only one player is allowed to play at each bay at any time.
12. All users are not allowed to make any practice swing or practice shot outside the practice bay area.
13. Non-players are not allowed to enter the practice bay area.
14. All persons including the Driving Range user are not allowed to go beyond the practice bay area to the open area.
15. All users must leave the practice bay as soon as their booked session/hour ends. They are not allowed to continue to use the bay or other practice bay. They shall also return all rental equipment as soon as possible.

16. No eating and/or drinking are allowed in the practice bay area.
17. All users of the practice bay must take all necessary precaution and care for the users' own safety and the safety of other persons.
18. For all users using the practice bay, if due to his or her negligence and/or improper conduct (including but not limited to negligence and/or improper conduct in making golf swing or golf shot), injury, death, and/or loss or damage to property are caused to any other persons, that person who causes the injury, death, and/or loss or damage to property shall be fully responsible for all legal consequences and shall indemnify the Association for all financial liability incurred including all legal costs and expenses.

Club Rental Regulations:

1. All hirers of golf clubs shall at the Reception and prior to using the rented clubs check and inspect the conditions of the clubs. If any damage is found they shall inform our staff, and the damaged club will be replaced. If any damage is found upon returning the rented clubs, the hirer shall be responsible for all repairing costs and expenses. If the rented club is lost, the hirer shall be responsible for the replacement costs. In either case, the deposit paid shall be forfeited and shall not be returned.
2. All the rented clubs shall only be used for practice or training purposes in the Driving Range. If due to the negligence and/or improper conduct on the part of hirer in using the rental clubs, injury, death, loss or damage to property are caused to any other persons, the hirer who causes the injury, death, and/or loss or damage to property shall be fully responsible for all legal consequences and shall indemnify the Association for all financial liability incurred including all legal costs and expenses.
3. All rented clubs must be returned to the Reception when the time for rental expires, otherwise they shall be treated as lost clubs.
